


The North Texas Commission formed the Regional Chamber Coalition (RCC) in 2018. Consisting of more than 100 chambers of commerce in the Dallas-Fort Worth Metroplex, the RCC creates a unified regional advocacy effort supporting pro-business legislation. For the past three state legislative sessions, the RCC has advocated for broad regional legislative priorities determined by our chamber partners.

The Accountability Index records the North Texas Delegation's votes on each of the RCC's priority bills that reached the House and Senate for final consideration.
